Registration Instructions for Returning and New Players.

- 1. Log in to your respective financial institution's website or app, and confirm your bank supports email transfer payments. For transfer payments, fees may apply, please contact your bank for details (usually less than \$2).
- 2. You will e-transfer your payment of \$135.00 up till March 1st, \$150.00 after March 1st per person to 2brianm@gmail.com, you may be asked to enter a verification code to confirm the recipient of the email.
- 3. Within the transfer please insert "Here are my 2018 league fees" and add your name(s) as a note to be sent along with your payment.
- 4. You will be asked to create a security question that will be answered only by Brian. The question should be "What is the acronym for the league and year". The answer to that question will be "ddspl2018". Once completed, it will be sent to the email that is specified.
- 5. Scan your completed registration form & waiver and e-mail both to 2brianm@gmail.com. That's all; you're now paid and registered for the 2018 season! If you have any questions or issues regarding the registration or payment process, please email 2brianm@gmail.com directly.
- 6. For those of you who cannot or are not comfortable with e-transfers please send a cheque, your completed registration form & waiver to the address on the top right corner of the registration form. Please make cheques payable to "Double Diamond Slo Pitch League", do not mail cash.

Returning players registered in full by March 1st will be assured a spot in the league, after that the league will open to new players and registration will be on a "first come, first served basis".
